  - i. Update on IBoss Solution – tabled

Phone System update – discussed history of bids, Special Meeting went down to three bids, no hosted program, discussed financial implications of bids as well as services offered, Hilltop was chosen as they offered good services, a new spreadsheet was requested by Mr. Healy, adequate funds are available, hub for Center School phones will be located at L.H.S.
- b. Facilities
  - i. Summer projects update – carpets cleaned in all schools, L.H.S. floors pre-

- sented problems, L.I.S. near completion, painting will be done where necessary.
- ii. Baseball field update – sod laid, clay coming, water lines are operating.
  - i. (continuation) Kitchens – examined and worked on, fire extinguishers certified, doors for Science wings replaced, 100 wing windows will be replaced, loading dock bid out
  - vi. LHS Gym Floor – basketball court will be done next July.
  - v. Intermediate School – building conditions – mostly done, roof coping bid out.
  - iv. Center School floor replacement update – two floors to be replaced (the last 2) and bids are out, 3<sup>rd</sup> floor room carpets need replacement (try to restore wood floor).
