REGULAR MEETING MINUTES

March 16, 2015- 7:00 p.m.

Call to Order: Chairman Barrows called the regular meeting to order at 7:00 pm.

PUBLIC HEARINGS

4. **Tomascak – 28 Old Forge Hollow Rd, March 16, 2015** - Special Exception Shop & Storage Use by a contractor/tradesman (Article V, Section 13A). For the record: Denise Schlesinger and Carol Bramley listened to the recorded tape of the February 17, 2015 meeting.

Summary: The hearing was opened at: 7:02 PM. Mr. Tomascak and Rita Van Stein presented several maps to the Commission. Chairman Barrows stated he did a site walk of Mr. Tomascak's property. Mr. Tomascak presented a plan for trees for the property line. Several letters were presented to the Commission.

Chairman Barrows read a letter from Anderson Cooper stating his support of the Special Exception Shop & Storage Use. A copy of the letter is in the file.

Mr. Tomascak stated he would plant Eight (8) – Six (6) foot Norway Spruce trees. The Commission spoke about the tree line, building and views to the neighbors from Mr. Tomascak's property.

Public Comment: Cathy Conroy, 90 Old Mount Town Road. Cathy Conroy asked if Mr. Tomascak's permit is approved, what will be allowed on the property for the business, i.e., signs or other outside storage. The Commission stated Mr. Tomascak will have to adhere to the regulations. The Committee stated that Dr. Tobin would visit the property to ensure compliance.

David Pavlick entered the meeting at 7:16 PM. David Pavlick was provided an overview of the meeting thus far from Chairman Barrows.

Dr. Tobin asked for a commitment from Mr. Tomascak to complete the planting of the trees. Mr. Tomascak stated as of July 1, 2015.

Carol Bramley made a motion to close the public hearing at 7:20 pm with William Conti seconding the vote. Vote of 5:0, will all in favor.

William Conti made a motion to approve the Tomascak – 28 Old Forge Hollow Rd - Special Exception Shop & Storage Use by a contractor/tradesman (Article V, Section 13A), with the condition that Mr. Tomascak would plant Eight (8) – Six (6) foot Norway Spruce trees which are to be planted no later than July 1, 2015. Carol Bramley seconded. Vote of 5:0, with all in favor.
